CONSIGNOR AGREEMENT FOR SALE OF GOODS

- The Consignor warrants that he or she has authority to enter into this agreement with the Auctioneer (Manshed Auctions Australia)
- The Consignor warrants that the items described above are the lawful property of the Consignor or that the Consignor has lawful authority to dispose of these items
- The Consignor warrants that he or she has not made any false representations regarding the condition, authenticity or age of the items being sold
- Anything said by the Auctioneer about an anticipated sale price is not legally binding but only offered as opinion to the Consignor for the purpose of guidance
- The Auctioneer is authorised to sell the items described above on behalf of the Consignor in accordance with the Auction Terms and Conditions, a copy of which has been inspected by the Consignor prior to signing this agreement
- The Consignor agrees that the items shall be sold by the Auctioneer with no guaranteed selling price unless the Auctioneer has specifically agreed to such in writing
- Any reserve price applying to any item is as described in the form above or else must be agreed to in writing by the Auctioneer before the commencement of the auction
- Unless otherwise agreed to in writing, the Auctioneer reserves the right to adjust by up to 10% the stated reserve price of any item that has been put to and passed at auction, in order to negotiate and achieve the sale of the item by way of private treaty following the auction
- The seller's commission on this consignment is as stated above on this form
- Prospective purchasers of the items shall be entitled to inspect the items at the auction location stated above either by appointment or during advertised viewing times
- Except by arrangement through Manshed Auctions Australia as the bidding Agent, the Consignor is not permitted to bid on his or her own items at auction, but if this is done and the Consignor ends up winning any of these items at auction, a buyer's premium of 27.5% plus GST will apply on these items in addition to the seller's commission
- The Auctioneer must account for the proceeds of the sale of the items to the Consignor within 14 days after payment by the Purchaser
- While the Auctioneer shall endeavour to take all reasonable care in handling and storing the consigned items, the Auctioneer only accepts the items on condition that the Auctioneer is not responsible for loss or damage of any kind
- The Auctioneer takes no responsibility for the items while in transit under any circumstances, and in its role as a common carrier advises each Purchaser to insure any purchased items while they are being transported

- In the event of a legal dispute over the ownership of the consigned items neither the Auctioneer nor its agents will be held legally liable for the disposal of the consigned items
